North East Gas Distribution Company Limited (NEGDCL) is a joint venture of Assam Gas Company Limited (AGCL) and Oil India Limited (OIL) having its registered office in 5th Floor, Central Mall, G.S. Road, Guwahati – 781005, Assam. NEGDCL is engaged in the development of City Gas Infrastructure in Assam and Tripura. NEGDCL is having its branch offices in Tezpur, Mangaldoi and Agartala.

NEGDCL proposes to acquire office space on outright purchase basis with clear and unambiguous title deeds etc. for establishing its Head Office therein and seeks expressions of interest from owners and authorized agents. The requirement is for 4000 to 5000 sq. ft (approx.) and on a single floor equipped with essential amenities in a ready for possession premises. The building should project a professional and aesthetically pleasing appearance and should be approved for office use.

Preferably, the offered space should be located in a building on GS Road, Guwahati with convenient accessibility. The premises must have adequate water, electricity and allied facilities:

- 1. The building should be in good condition and well maintained.
- 2. There should be standby generator of sufficient capacity for uninterrupted power supply.
- 3. 24 hours potable water supply with adequate water treatment facilities.
- 4. Electrical load should be adequate for sustaining all utilities in the office space.
- 5. Adequate and safe lift facility if the building is of more than two floor (GF+ FF).
- 6. The building shall have emergency exit and adequate fire protection facilities.
- 7. There should be adequate toilet facilities which should be both clean and well maintained.
- 8. Premises offering parking space for minimum 5 cars.

Bidder has to submit the following necessary documents as mentioned below along with the Expression of Interest Form:

- 1. Copy of registered Ownership proof along with chain of Title Deeds (if applicable)
- 2. Copy of Building Sanction Plan along with floor layout
- 3. Architectural MAP showing Carpet Area of floor
- 4. Copy of Occupancy /Completion Certificate
- 5. Undertaking that Property is free of any litigation (in original)
- 6. Undertaking for Non Encumbrance Certificate to be issued from concerned authority, if any, and NOC to be provided before the sale from the loan institution (in original)
- 7. Copy of Last 1 year property tax receipts
- 8. Copy of any document authorizing commercial usage of Property
- 9. Any document authorizing ITES/Commercial usage of Property, which provide clear picture of operation office activities without any hurdle.
- 10. Duly notarized Authorization Letter, in case the EOI is submitted by a representative/broker/Joint owner and not by the original owner.

11. Any other relevant document, if any.

Interested parties possessing built-up areas as stated above, having clear legal title are invited to send their Expression of Interest physically to NEGDCL's registered office in the prescribed template (enclosed) with furnishing details like name of the owner, contact details, location of the office space, size, amenities, etc.

Representative will have to enclose the letter of authority along with the expression of interest. Otherwise the offer is liable to be considered null and void at any stage as per the decision of NEGDCL. No brokerage will be paid by NEGDCL.

Selection of the organization shall be made based on the details submitted in the EOI. The offered premises will be inspected for preliminary short-listing by NEGDCL. This may include carrying out the measurements and valuation of the offered premises and its suitability for setting up of the office. Selected organization will be informed subsequently to submit the detailed technical offer and financial offer and terms and conditions.
