1.0 INTRODUCTION

- 1.1 North East Gas Distribution Company Limited (NEGDCL) is a consortium of Assam Gas Company Limited (AGCL) and Oil India Limited (OIL) having its registered office in 6th Floor, central Mall, G.S. Road, Kamrup. NEGDCL won authorization for C3 geographical areas (GAs) in the northeast region of India viz. GA of Darrang, Udalguri, Sonitpur, Bishwanath, Lakhimpur and Dhemaji districts in Assam (GA ID: 11.03) and GA of Sepahijala and South Tripura districts (GA ID: 11.56) and GA of North Tripura, Khowai, Dhalai and Unakoti districts in Tripura (GA ID:11.57)
- 1.2 NEGDCL intends to develop the City Gas Distribution (CGD) Network in all districts of the GA so as to leverage the synergies anticipated during infrastructure creation, operations & maintenance and administration of each of the individual GA.
- 1.3 VCS Quality Services Pvt Ltd (VCS) (hereinafter referred as consultant), has been appointed by NEGDCL as the Engineering, Procurement & Construction Management Consultant (EPCM) services for CGD Network in the district of Darrang, Udalguri, Sonitpur, Bishwanath, Lakhimpur and Dhemaji in Assam GA and in the district of Khowai and Sipahijala in Tripura GA.

2.0 BRIEF DESCRIPTION OF PROJECT

2.1 The present project is the extension of pipeline network in the district of Darrang, Sonitpur, Bishwanath Chariali and Dhemaji in Assam for supplying Natural Gas to Domestic, Commercial and Industrial consumers. It is proposed to Supply of 1200 SCMH Gas Driven Engine Compressor for City Gas Distribution Project in the State of Assam GA.

3.0 BRIEF SCOPE

3.1 The Scope of work includes Design, Engineering, Manufacturing, Assembly, Inspection, Packaging, Testing, Supply and Transportation of 1200 SCMH Gas Driven Engine Compressor for City Gas Distribution Project at Darrang, Udalguri, Sonitpur, Bishwanath, Lakhimpur and Dhemaji districts in Assam (GA ID: 11.03).

- 3.1.1 This document shall be read in conjunction with Schedule of Rates, specifications, standards, drawings and other documents forming a part of the Tender Document
- 3.1.2 The above quantities are indicative and for evaluation purpose only. Purchaser reserves the right to increase or decrease at the time of award.
- 3.1.3 The bidder has to quote for full quantity of SOR item. Partial bid shall be liable for rejection.





- 3.1.4 For detailed Scope of work and specifications, refer Technical volume II of II.
- 3.2 Operation & Comprehensive Maintenance Period
- 3.3 Bidder shall provide Operation & Comprehensive Maintenance during warranty period. Warranty period shall be as defined in tender document. Further bidder shall provide Operation & Comprehensive maintenance for 4 (four) years from the date of end of warranty period. However, maximum duration of contract for operation & comprehensive maintenance during warranty and post warranty period shall be limited to 60 months from the date of receipt of last Compressor at NEGDCL store / site.
- 3.4 In case compressor package is commissioned after six months from the receipt of last Compressor for any reason attributable to Purchaser, the operation & comprehensive maintenance rates for last supplied package shall be applicable from date of commissioning.

4.0 DURATION AND DELIVERY SCHEDULE

4.1 Delivery : The supply of 1200 SCMH Gas Driven Engine Compressor

Package including all Auxiliaries, shall be delivered within 16

weeks from date of LOA.

4.2 Basis of Delivery : The basis of delivery shall be FOT, NEGDCL Site/Store at

NEGDCL Site in Sonitpur district, Assam.

4.3 PRS Applicability : For applicability of PRS calculation date of Lorry Receipt (LR) shall

be considered as date of delivery.

4.4 Duration of O&M : **For Operation**: The duration for operation of compressor package

shall be five (05) years (1 year during warranty and 04 years post

warranty).

For Maintenance: The duration for comprehensive maintenance

shall be four (04) years (post warranty).

Note: First year comprehensive maintenance is included in

warranty period of compressor package.

- 4.5 Two separate contracts shall be issued to successful bidders against this tender as below:
 - i) Supply, Installation, Commissioning & Testing etc.
 - ii) Operations & Comprehensive maintenance Services

If required, NEGDCL have right to extend the Operations and Comprehensive Maintenance contract for the period of 6th to 10th years;

Separate contract will be awarded for providing the operation and comprehensive maintenance services (including major overhaul for compressor) for another five years i.e. 6th to 10th year:

- i) For Comprehensive maintenance services: To derive rate for sixth and subsequent years (6th to 10th year), 10% annual escalation YoY basis) on awarded rate of 5th Year shall be considered.
- ii) For Operations: To derive rate for sixth and subsequent years (6th to 10th year), 10% annual escalation YoY basis on awarded rate (excluding wage components, variation of which is payable on actual basis) of 5th Year shall be considered. It will be responsibility of bidder to ensure the payment of minimum wages of State to workmen engaged for operations.





5.0 BID VALIDITY

5.1 Bid should be valid for 90 days from the date of schedule submission.

6.0 BIDDING PROCEDURE

- 6.1 Bidding will be conducted through **Open Domestic Competitive Bidding basis**. Single stage two bid system is adopted for this tender.
- opening 6.2 submission of bids will through e-tenderina and be mode https://www.tenderwizard.com/pvt. Tender document can be downloaded from the website https://www.tenderwizard.com/pvt. Payment of requisite e-Tender Processing Fee (nonrefundable) shall be made to Tenderwizard's account through online mode vide the link on their eprocurement portal as specified in the tender document before bidding. Any bidder who does not pay this processing fee to Tenderwizard's will not be able to proceed further for bid submission. NEGDCL/ VCS shall not be accountable to any payment made in favour of M/s Tenderwizard.

PART- I (UN-PRICED BID)

Un-priced bid must be completed with all technical details along with all other required documents including price schedule **WITH PRICE BLANKED OUT** etc. as per clause no. 23.1 of ITB.

PART-II (PRICED BID)

Priced bid shall contain only the prices without any conditions as per clause no. 23.2 of ITB.

8.0 BIDDER EVALUATION CRITERIA (BEC)

8.1 **TECHNICAL**

8.1.1 The bidder should have regularly supplied, installed, tested and commissioned Gas Engine driven CNG compressor having flow capacity of 650 SCMH or higher for at least the last three years, ending 31st March 2024.

And

8.1.2 The bidder should have successfully completed similar supply, for at least one number Gas Engine driven CNG compressor having flow capacity of 650 SCMH or higher in the last 7 years, reckoned from the tender floating date.

Similar supply Definition (Refer clause 8.1.2): -

"The bidder should have Designed, Engineered, Tested, Supplied, Installed and Commissioned at site Gas engine driven of Compressor package having 650 SCMH or higher Capacity with discharge pressure up to 250 kg/cm2 to any CGD company in India.

- 8.1.3 In case bidder submitted document for "similar Supply" qualification including CAMC & Operation cost, in that case CAMC & operational cost for compressor package shall not be considered for technical bid evaluation.
- 8.1.4 Bidder shall submit ISO/ IMS certificates, valid PESO approvals or renewal application for PESO approval & other relevant documents for supply of 1200 SCMH Gas Driven Compressor as applicable along with the technical bid.

8.1.5 Other technical requirement

At least one No. Gas engine driven CNG Compressor having capacity 1200 SCMH should be in successful operation for at least 1 year reckoned from the tender floating date.

8.2 **FINANCIAL**:

8.2.1 **Annual Turnover**

The minimum annual turnover achieved by the bidder as per their audited financial results during any one of the preceding three (03) financial years shall meet the turnover requirement of INR 1,99,87,000/-

8.2.2 Net Worth

Bidder's Net worth should be positive as per the preceding financial years audited financial statement.





8.2.3 Working Capital

The minimum working capital of the bidder as per the last audited financial statement for immediate preceding financial year shall be **INR 39,97,000/-**

Note:

- a. If the bidder's working capital is inadequate, the bidder shall submit a letter from the bidder's bank, having net worth not less than Rs.100 Crore, confirming the availability of the line of credit to cover the inadequacy of working capital required as above. Line of credit must contain Tender No., Tender Description and Client Name. Letter for line of credit must be issued by a scheduled bank. Format of line of credit letter from bank has been enclosed at Annexure-2.
- b. In case of tenders having bid submission date up to 30th September of the relevant financial year, and audited financial results of the immediate preceding financial year is not available, the bidder can submit the audited financial results of the three years immediately prior to that. Wherever the closing date of the bid is after 30th September of the relevant financial year, bidder has to compulsorily submit the audited financial results for the immediate 3 preceding financial years.
- c. Evaluation shall be done on Overall basis to arrive at the lowest evaluated cost to Purchaser

Notes to BEC:

- a. The amount mentioned under above qualification Criteria is inclusive of GST/ Service taxes as applicable.
- b. In case the bidder is executing a Rate Contract of above nature which is still running and the contract value executed till last day of the month previous to the one in which tender is invited is equal to or more than the minimum prescribed value mentioned in the BEC, such experience will also be taken into consideration provided that the bidder has submitted satisfactory work execution certificate to this effect issued by the end user / owner / authorized consultant.
- c. A job executed by a bidder for its own plant/ projects cannot be considered as experience for the purpose of meeting requirement of BEC of the tender. However, jobs executed for Subsidiary / Fellow subsidiary/ Holding company work executed against orders fulfilling above BEC criteria will be considered as experience for the purpose of meeting BEC subject to submission of tax paid invoice(s) duly certified by statutory auditor of the bidder and challan towards payments of statutory tax in support of the job executed for Subsidiary/ Fellow subsidiary/ Holding company. Such bidders to submit these documents in addition to the documents specified in the bidding documents to meet BEC.
- d. The required warrantee cover of the complete package shall be provided by compressor supplier.
- e. Further, one Gas Engine Driven compressor OEM shall authorize only one packager and a packager shall offer compressor package of only one compressor OEM.

Special Note for Bidders information:

• If bidder is dealer/subsidiary/packager of manufacturer, they have to meet the financial criteria. They have to submit a letter from manufacturer authorizing them to submit the bid on





behalf of manufacturer. A latest confirmation by the manufacturer to this effect shall be submitted by the bidder along with the bid in the attached format as Annexure-A. Manufacturer has to meet the technical BEC. Packages supplied through dealer/subsidiary/packager of manufacturer will be considered for qualification as well.

- Mechanical Run Test (MRT) of 1200 SCMH Compressor & String Test of the compressor package may be witnessed by TPI / Purchaser at the manufacturing facility of compressor block OEM.
- Manufacturer/ OEM on whose behalf Authorized Service dealer /packager is submitting the
 offer shall have the prime responsibility of providing unconditional guarantee/warranty and
 after sale support to the purchaser during guarantee/warranty and comprehensive
 maintenance period. A confirmation by the Manufacturer/ Packager to this effect shall be
 submitted along with the bid.

- It shall be noted that in case bidder fails to submit requisite details/ documents, the bid submitted by bidder is liable to be rejected.
- NEGDCL/ VCS decision shall be final with respect to bidder's qualification based on bid evaluation criteria.





9.0 EMD / BID SECURITY

- 9.1 All bids must be accompanied by a bid security amount of INR 15,00,000/- only.
- 9.2 EMD shall be in favour of North East Gas Distribution Company Limited (NEGDCL) and shall be acceptable in the form of Crossed Demand Draft (Payable at Kamrup, Assam) or Bank Guarantees (B.G.) in the prescribed pro-forma from Scheduled Commercial banks in India/ Indian Branch of Foreign Bank.

- 9.6 PSUs and firms registered as Micro/Small Enterprise with MSME are exempted from furnishing Earnest Money Deposit (EMD) / Bid Security, (subject to their enclosing a copy of latest and valid registration certificate for the tendered products/services) with their bid. Enterprise which have been re-classified as 'Medium' enterprise from their earlier status as 'Micro' or 'Small' enterprise in Udyam registration certificate shall be exempted from submitting EMD. The bidders shall be given this exemption for a period of three years from the date of such upward change in their MSME status. Bidders are required to submit Udyam registration certificate(s) meeting above stated conditions for exemption under this provision, failing which bid shall be rejected. Declaration as per Annexure-1 to be mandatorily submitted along with exemption certificate by such bidders. Traders / Dealers / Distributors / Stockist / Wholesalers are not entitled for exemption of Earnest Money Deposit (EMD) / Bid Security.
- 9.7 The Chartered Accountant (CA) certificate along with UDIN No. of Valid document and the same Chartered Accountant (CA) Certificate should be dated after the date of floating of tender & shall be specific to the tender for which bid is being submitted. Format of the certificate from Statutory Auditor / Chartered Accountant (CA) is attached as "Form 15" in bid document.
- 9.8 Accordingly, in case of upward change in status, MSE bidder is required to submit the previous certificate also along with **certificate from Statutory Auditor / Chartered Accountant (CA)** as 'Form 15' in bid document to get the MSE benefit.
 - Bidders must verify their latest status of MSME registration as on date of bid submission.
 - Note: The notification s.o.4926 (e) dated 18.10.2022 is applicable to the upward change took place in the status of Udyam Registered Enterprises only for availing the benefits of the schemes as per





the policy or guidelines, not on erstwhile Udyog Aadhaar Memorandum(UAM). Any reference to Udyog Aadhaar Memorandum (UAM) certificate shall not be considered for such EMD exemption."

9.9 Subject to exemption permissible, offers without Earnest Money Deposit (EMD) / Bid Security will not be considered and will be summarily rejected.

10.0 PRE-BID MEETING

- 10.1 The bidder(s) or his representative who intend to bid and who have either purchased the tender document or paid the tender fees for downloaded document are invited to attend a pre bid meeting which will take place on date specified in the tender document. Bidder(s) queries, if any must reaches Consultant via E-mail at least Two (02) days prior to pre bid meeting date.
- 10.2 Non-attendance of the pre-bid meeting will not be a cause for disqualification of the bidder.
- 10.3 Instructions to bidders for Pre-bid meeting through video conferencing:

In case of pre-bid meeting through video conferencing, all bidders intending to attend pre-bid meeting must send their interest through email along with details of registration on e-tender website. E-mail received from bidders within due date and time shall be invited formally through email to attend the meeting. Instructions to bidders:

- (i) All the Bidders who have submitted their registration details and interest to attend the prebid meeting in email up 2 hours prior to start of scheduled meeting will be invited to join as guests through the link shared in mail.
- (ii) Upon joining the video conference, bidders have to mention their organization name as well as representative name.
- (iii) Bidders shall be allowed to discuss their gueries in sequence of their responses received.
- (iv) Time slot shall be allotted to each bidder to ask his queries.
- (v) Recording shall be done for pre-bid meeting.
- (vi) Clarifications or queries raised shall be responded to during meeting or through subsequent email.

- 11.4 NEGDCL reserves the right to reject any or all the bids received at its discretion without assigning any reason whatsoever.
- 11.5 Canvassing in any form by the Bidder or by any other agency on their behalf may lead to disqualification of their Bid.
- 11.6 All documents submitted should be in English only.
- 11.7 Directives issued by Govt. of India from time to time shall be applicable during bid evaluation
- 11.8 In case any bidder is found to be involved in cartel formation, their Bid will not be considered for evaluation / placement of order. Such Bidder will also be debarred from bidding in future as per sole discretion of Owner.
